1. Central Region water board through the Government of Malawi has received funding under the Public Sector Investment Program (PSIP) toward the cost of the Project for **Rehabilitation Works for Ntchisi Water Supply Scheme**.
2. The Central Region Water Board now invites sealed Bids from eligible Bidders for the following Works:
 - Upgrading of the Kaombe River intake structure,
 - Installation of a 2.5km Raw Water Gravity Main

The Works shall be completed within 6 months.

3. Bidding will be conducted through national competitive procurement using Request for Bids (RFB) as specified in the Malawi Public Procurement and Disposal of Assets act 2025 guidelines, and is open to all eligible Bidders as defined in the Procurement Regulations.
4. A non-mandatory pre-bid site visit meeting shall take place on **Wednesday 26th August 2026** at Central Region Water Board Offices (Ntchisi) from **08:30 Hours**.
5. Interested eligible Bidders may obtain further information from the Central Region Water Board and inspect the Bidding document during office hours 07:30 to 16:30 hours (local time) at the address given below.
6. The Bidding document in English may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of MWK 50,000. The method of payment will be cash at Central Region Water Board Head Office (**Lilongwe**) Cashier's Pay Point.

7. Bids must be delivered to the address below on or before **Monday 31 August, 2026**, 10:00 local time. Electronically submitted bids will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **Monday 31 August, 2026**, 10:00 local time after closure of receiving bids.
8. All Bids must be accompanied by a Bid Security which is 2 percent of the total bid price in Malawi kwacha.
9. Bids should be submitted in 4 copies (One original and 3 copies).
